- 5 The bids will be opened in the presence of Bidders' representatives who choose to attend at 14.00 PM Nepal times on 31th December, 2020 (16th Poush 2077) at the office of Province Health Logistics Management Centre, Janakpurdhm, Dhanusha, Nepal. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 23,00,000.00 , which shall be valid for 30 days beyond the validity period of the bid
