1. The **Province Health Logistic Management Center, Janakpurdham**, invites **electronic** bids from eligible bidders for the procurement of **MP/PHLMC/NCB/GOODS-15/2082-83.; The Procurement and Supply of Medicine for Non-Communicable and Mental Disease**. Under National competitive bidding – Single Stage Single Envelope procedures.

4. Pre-bid meeting shall be held at **Province Health Logistic Management Center Janakpurdham** at 10<sup>th</sup> Jun 2026
5. Electronic bids must be submitted to the office **Province Health Logistic Management Center Janakpurdham** through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 Noon** on 18<sup>th</sup> Jun 2026 Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 PM** on 18<sup>th</sup> Jun 2026 at the office of **Province Health Logistic Management Center, Janakpurdham**. Bids must be valid for a period of **120 Days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **500000.00** which shall be valid for 30 days beyond the validity period of the bid 90 Days.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
